§2 Revocation rights for non-EU based customers

Our products are provided “as is” without warranty of any kind, either expressed or implied.

§3 Revocation rights for EU based customers

You have the right to cancel the contract without giving reasons. The revocation period is fourteen days from the date of conclusion of the contract. In order to exercise your right of withdrawal, you must inform us (see §1) by means of a statement, that you may send by post, fax, e-mail or contact form on the website. The statement has to contain a clear decision about your withdrawal from a contract. You can use the attached revocation template form for this purpose. In order to comply with the revocation period, it is sufficient to send the notification of the exercise of the right of revocation before the end of the revocation period.

§4 Consequences of revocation

If you revoke the Agreement, we shall reimburse you for all payments we have received from you, without delay and at the latest within fourteen days of the date on which we receive notification of your revocation of the Agreement. For this refund, we will use the same means of payment that you used for the original transaction, unless expressly agreed otherwise with you. In no event will you be charged for this refund.

§5 Consent to early expiration of revocation rights for EU based customers

(Directive on Consumer Rights 2011/83/EU)

In the case of a contract for the supply of digital content that is not on a physical data carrier, the right of withdrawal expires if we began the execution of the contract after you:

1. had expressly consented to us beginning with the performance of the contract prior to expiry of the withdrawal period, and
2. had acknowledged that by your consent, upon the performance of the contract having commenced you would lose the right to withdraw from the contract.
